FOR WINDSTREAM COMPREHENSIVE PLAN OF GROUP INSURANCE**

This is a summary of the annual report for Windstream Comprehensive Plan of Group Insurance, EIN 20-0792300, Plan No. 501, for the period January 1, 2015 through December 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA). The company has committed itself to paying certain claims incurred under the terms of the plan.

**Insurance Information**

The plan has contract(s) with Delta Dental of Arkansas, Life Insurance Company of North America, Standard Life, United Healthcare Insurance Company, Express Scripts Inc, Vision Service Plan, and Magellan Behavioral Health to pay health, dental, vision, life insurance, temporary disability, long-term disability, prescription drug, and employee assistance program claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2015 were \$15,181,325.

Because they are so called “experience-rated contracts,” the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2014, the premiums paid under such “experience-rated” contracts were \$12,464,693 and the total of all benefit claims paid under these contracts during the plan year was \$7,379,413.

The company has committed itself to paying certain claims incurred under the terms of the plan.

**Insurance Information**

The plan has contract(s) with Delta Dental of Arkansas, Spectera Vision, Standard Life, Express Scripts Inc and United Healthcare Insurance Company to pay health, dental, vision, life insurance, and prescription drug claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2015 were \$3,820,475.

Because they are so called “experience-rated contracts,” the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2013, the premiums paid under such “experience-rated” contracts were \$626,661 and the total of all benefit claims paid under these contracts during the plan year was \$2,587,729.

**SUMMARY ANNUAL REPORT  
FOR Active Dental and LEXCOM RETIREE MEDICAL PLAN**

This is a summary of the annual report for Lexcom Retiree Medical Plan, EIN 20-0792300, Plan No. 503, for the period January 1, 2015 through December 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA). The company has committed itself to paying certain claims incurred under the terms of the plan.

**Insurance Information**

The plan has contract(s) with Ace American Insurance Company, Delta Dental of Arkansas, Hartford Life & Accident Insurance Company, Life Insurance Company of North America and Sterling Life – Med D RX Drug Plan Insurance Company to pay health, and prescription drug claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2015 were \$11,008,798.

**Basic Financial Statement**

Benefits under the plan are provided through a trust fund. Plan expenses were \$11,221,883. These expenses included \$11,008,798 in premiums paid and \$203,085 in administrative expenses, which includes taxes. A total of 12,472 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$0 as of December 31, 2015, compared to \$4,997,655 as of January 1, 2015. During the year the plan experienced an increase in its net assets of \$103,094. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had income of \$74,768 from earnings on investments.

**SUMMARY ANNUAL REPORT  
FOR WINDSTREAM 401(K) PLAN**

This is a summary of the annual report for Windstream 401(k) Plan, EIN 20-0792300, Plan No. 009, for period of January 01, 2015 through December 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

Benefits under the plan are provided through a trust fund. Plan expenses were \$98,611,063. These expenses included \$632,398 in administrative expenses, \$96,162,992 in benefits paid to participants and beneficiaries, and \$1,815,673 in other expenses. A total of 11,919 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$825,001,173 as of December 31, 2015, compared to \$870,767,048 as of January 01, 2015. During the plan year the plan experienced a decrease in its net assets of \$45,765,875. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$52,720,757 including employer contributions of \$24,667,567, employee contributions of \$48,582,104, other income of \$2,559,362, realized losses of \$10,162,190 from the sale of assets, and losses from investments of \$12,926,086.
