Your Rights

This is a summary of the annual report for Windstream Comprehensive Plan of Group Insurance, EIN 20-0792300, Plan No. 501, for the period January 1, 2017 through December 31, 2017. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA). The company has committed itself to paying certain claims incurred under the terms of the plan.

Insurance Information

The plan has contract(s) with Delta Dental of Arkansas, Life Insurance Company of North America, Standard Life, United Healthcare Insurance Company, Express Scripts Inc, Vision Service Plan, and Magellan Behavioral Health to pay health, dental, vision, life insurance, temporary disability, long-term disability, prescription drug, and employee assistance program claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2017 were \$18,106,406.

Because they are so called “experience-rated contracts,” the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2016, the premiums paid under such “experience-rated” contracts were \$18,068,437 and the total of all benefit claims paid under these contracts during the plan year was \$13,141,080.

The total premiums paid for the plan year ending December 31, 2017 were \$2,208,919.

Of the total insurance premiums paid for the plan year ending December 31, 2017, the premiums paid under such “experience-rated” contracts were \$1,463,749 and the total of all benefit claims paid under these contracts during the plan year was \$1,761,750.

SUMMARY ANNUAL REPORT FOR WINDSTREAM 401(K) PLAN

This is a summary of the annual report for Windstream 401(k) Plan, EIN 20-0792300, Plan No. 009, for period of January 01, 2017 through December 31, 2017. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$117,741,584. These expenses included \$782,222 in administrative expenses, \$114,734,986 in benefits paid to participants and beneficiaries, and \$2,224,376 in other expenses. A total of 13,922 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,115,895,739 as of December 31, 2017, compared to \$874,585,824 as of January 01, 2017. During the plan year, the plan experienced an increase in its net assets of \$241,309,915. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$174,846,298 including employer contributions of \$27,501,002, employee contributions of \$52,656,348, other income of \$4,160,001, realized losses of \$7,861,690 from the sale of assets, and gains from investments of \$98,390,637.
