Your Rights

SUMMARY ANNUAL REPORT FOR EARTHLINK, INC. 401(K) PLAN

This is a summary of the annual report for the EARTHLINK, INC. 401(K) PLAN, Employer Identification Number 51-0553722, Plan Number 001, for the plan year January 01, 2017 through July 31, 2017. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a trust fund. Plan expenses were \$33,732,291. These expenses included \$201,823 in administrative expenses and \$33,337,323 in benefits paid to participants and beneficiaries, \$193,145 in certain deemed and/or corrective distributions, and \$0 in other expenses. A total of 0 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$0 as of July 31, 2017, compared to \$153,767,702 as of January 01, 2017. During the plan year the plan experienced a change in its net assets of \$153,767,702. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$17,139,020, including employer contributions of \$642,754, employee contributions of \$3,293,632, other contributions/other income of \$247,477, and earnings from investments of \$12,955,157.
