Your Rights

You have the right to:

SUMMARY ANNUAL REPORT FOR WINDSTREAM 401(K) PLAN

This is a summary of the annual report for Windstream 401(k) Plan, EIN 85-2049794, Plan No. 009, for period January 01, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$111,599,364. These expenses included \$626,153 in administrative expenses, \$108,927,286 in benefits paid to participants and beneficiaries, and \$2,045,925 in other expenses. A total of 14,585 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,098,909,188 as of December 31, 2022, compared to \$1,335,898,571 as of January 01, 2022. During the plan year, the plan experienced a decrease in its net assets of \$236,989,383. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of (\$125,390,019), including employer contributions of \$27,389,586, employee contributions of \$56,204,896, earnings from investments of (\$212,574,236), and other income of \$3,589,735.

SUMMARY ANNUAL REPORT FOR WINDSTREAM SERVICES, LLC WELFARE BENEFIT PLAN

This is a summary of the annual report of the Windstream Services, LLC Welfare Benefit Plan (Employer Identification Number 85-2049794, Plan Number 501) for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Windstream Services, LLC has committed itself to pay certain health, prescription drug, flexible spending account, dental, severance pay, and temporary disability claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Standard Insurance Company, Magellan Healthcare, Life Insurance Company of North America, Metlife Legal Plans, Vision Service Plan, Aetna Life Insurance Company and Included Health to pay certain life insurance, employee assistance program, long-term disability, legal, vision, accident, critical illness, expert medical opinion and accidental death and dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$15,062,328.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2022, the premiums paid under such "experience-rated" contracts were \$5,711,868 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$4,667,732.
