### **Your Rights**

You have the right to:

- Receive a copy of the full annual report, or any part, on request. You will need to pay copying costs of 25 cents per page.

## **SUMMARY ANNUAL REPORT For Windstream 401(k) Plan**

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan for Windstream 401(k) Plan, EIN 85-2049794, Plan No. 009, for period January 1, 2023 through December 31, 2023. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Basic Financial Statement**

Benefits under the plan are provided by a trust fund. Plan expenses were \$140,706,657. These expenses included \$643,777 in administrative expenses, \$137,438,226 in benefits paid to participants and beneficiaries, and \$2,624,654 in other expenses. A total of 13,123 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,229,434,573 as of December 31, 2023, compared to \$1,098,909,188 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$130,525,385. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$271,232,042, including employer contributions of \$26,521,768, employee contributions of \$54,664,806, earnings from investments of \$184,853,540, and other income of \$5,191,928.

This is a summary of the annual report of the Windstream Services, LLC Welfare Benefit Plan, EIN 85-2049794, Plan No. 501, for period January 1, 2023 through December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Windstream Services, LLC has committed itself to pay certain self-insured Medical, Prescription Drug, Flexible Spending Account, Dental, Short-term Disability, and Severance claims incurred under the terms of the plan.

**Insurance Information**

The plan has contracts with Magellan Healthcare, Life Insurance Company of North America, MetLife Legal Plans, Vision Service Plan, Included Health, Standard Insurance Company, and Cigna Health and Life Insurance Company to pay Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Legal, Critical Illness, Hospital, Accident, and Expert Medical Opinion claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$13,259,806.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2023, the premiums paid under such "experience-rated" contracts were \$5,402,333 and the total of all benefit claims paid under these contracts during the plan year was \$5,560,780.
